This Cookies Policy describes how UICOM – FZCO uses cookies on our website and platform.

Cookies are small pieces of data that are stored in the memory of a computer, mobile phone or other device after visiting websites. Cookies are used to maintain the operation of websites, platforms and to collect statistics.

Web beacons are small graphic images that may be added to our website, platform and newsletters, and are usually used in combination with cookies to identify users and their behavior.

The information we collect using cookies helps us analyze how our website, platform is used so that we can make it as convenient and functional as possible. Cookies can also make your work on the site, platform easier and ensure that the advertising you see matches your search queries on the Internet.

When navigating to a website, platform, the user may accidentally receive cookies from other websites or web servers, which are so-called "third-party" cookies. This happens because the website you are visiting may contain elements such as images, maps, sound files, links to individual web pages on different domains located on other servers.

TYPES OF COOKIES ON THE SITE AND PLATFORM

Our website, platform uses different types of cookies. Some cookies may be placed on your device by other data operators: Google, Google Analytics, and others. Such cookies are called "third party" cookies. In such cases, we are not responsible for any actions or policies of third parties.

We use the following cookies on our website:

__cfduid	The _cfduid cookie helps detect malicious visitors to our customers' websites and minimizes blocking of legitimate users. It can be placed on end-user devices to identify individual clients with a common IP address and apply security settings for each client. This is necessary to support security features
_csrf-frontend	This cookie helps prevent virus attacks and has a protective function
_ym_d	Stores the date of the visitor's first visit to the site
_ym_uid	Helps distinguish visitors to the service
_	Used to determine whether the visitor has ad blockers

_ym_visorc_234234	Used for the correct operation of Webvisor

lk-	Unique User ID
lk-session-front	User Session ID

The length of time a cookie remains on your device depends on whether the cookie is a “persistent” or “session” cookie. Session cookies will remain on your device until you stop browsing. Persistent cookies remain on your device after browsing until they expire or are deleted.

We use session cookies to assign a unique identifier to your device each time you visit our site. Session cookies are deleted once you close your browser. They are used to maintain the functionality of our site, platform and to analyze your use of the site and our platform.

Where appropriate, we use persistent cookies, which are not deleted immediately after you close your web browser but remain on your device for a set period or until you delete them. Each time you visit our site, platform, our web server recognizes persistent cookies stored on your device. By assigning a unique identifier to your device, we create a database of your activities and preferences.

CONTROL OVER THE USE OF COOKIES

You can enable, disable or delete cookies using the browser you use to view the site, platform. To do this, follow the instructions provided by your browser (usually located in the “help”, “tools” or “edit” section).

Please note that if you decide to disable or decline cookies, you may not be able to access some parts of this website.
